The Fire Tables

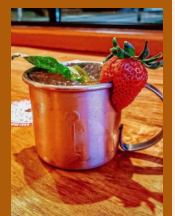
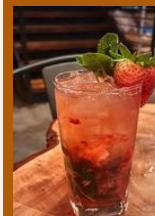

Booking Policies

- **Guarantees:** Any group hosting an event at Jekyll & Hyde must attach a \$250 deposit in addition to a signed contract in order to guarantee the selected day and time. Management reserves the right to cancel any booking without proper deposit. Event host will provide a guaranteed number of guests 14 days prior to event date. Food, beverage, and set up arrangements are to be finalized at this time. Event bill must be paid in full the day of or prior to the event. . Should event host want to provide an open bar on a per drink basis a credit card must also be given.
- **Damages/ Additional Cost:-**The contracting party here by agrees to be fully and solely responsible for any damage and extra cost in any way relating to the event, and to be fully and solely responsible for any damage or destruction of Jekyll & Hyde Taphouse and Grill caused by the contracting party or any of its agents, guests or invitees. The contracting party further agrees any and all cost of repair or damage to the facility caused by itself or its agents, guests or invitees, or occurring during its agents, guests or invitees use of the facility pursuant to this contract.
- **Indemnification:** The contracting party agrees to indemnify, defend and hold harmless Jekyll & Hyde Taphouse and Grill/J&H Belmont LLC and its officers from any liability, claims, damages, loss or expense (including attorney's fees, court cost and consequential damages) relating in any way to the event or caused by the use of the facility by the contracting party, the contracting parties guest or invitees, or the contracting parties agents, such as musicians, decorators, photographers and others who are working for the contracting parties.
- **Force Majeure Conditions:** The contracting party agrees that Jekyll & Hyde Taphouse and Grill/ J&H Belmont LLC and its officers shall not be liable for losses, damages (Including attorney's fees, court costs, and consequential damages), detention, delay or failure to preform in whole or in part resulting from causes beyond its control, including but not limited to acts of God, acts or omissions, fires, weather conditions, power failures, strikes, riots, embargos, delays in transportation, inability to obtain supplies or requirements, or regulations of the United States Government or any other civil or military authority (to include any local legislation regarding liquor license requirements). Delays or nonperformance excused by this provision shall not excuse payment of any amount owed by the contracting party at the time of this occurrence. If an event is cancelled in whole or part because of a force majeure condition, a complete or partial refund will be made accordingly to the contracting party no later than 14 days after the date of the event.
- **Conduct:-**Jekyll & Hyde Taphouse and Grill is a smoke free facility. A smoking area is designated in the beer garden/ outdoor patio area. Smoker pots and ashtrays will be provided. Contracting party agrees and warrants that there will be no consumption of alcohol by persons under age 21. Contracting party shall indemnify and hold J&H Belmont LLC and its officers, harmless from all liability for improper use of alcohol. No outside alcohol is permitted in or on the premises of Jekyll & Hyde Taphouse and Grill. Disparaging remarks or any type of physical violence will not be tolerated and will be caused for immediate expulsion. Contracting party and guest shall use the premises in a considerate manner at all times. Conduct deemed disorderly at the sole discretion of J&H Belmont LLC staff shall be grounds for immediate expulsion from the premises and conclusion of the rental period. In such cases no refund of the rental fee shall be made.
- **Attorney Fees:** In the event J&H Belmont LLC retains the services of an attorney to represent its interest in regard to bring in action for the recovery of damages or other charges, the contracting party agrees to pay a reasonable attorney fee of not less than \$1000.00 or 20% of the sum sued for, whichever is greater, plus the cost of any legal action.
- **Lost and Found:-** J&H Belmont LLC takes no responsibility for personal effects and possessions left on premises during or after any event.
- **Decorations:** Decorations may not be fastened to the wall with nails, staples, push pins or screws. Any tape must be properly removed. In an extreme case of any wall damage, the card on file will be charged. Absolutely NO confetti of any kind is allowed. This includes confetti balloons. A \$300 clean up fee will be charged if this rule is not followed.
- **Promotions and Copyright:-**J&H Belmont LLC shall have the right to take photographs at the event for the purpose of advertising and marketing the event space. All rights to, and the use of these images shall belong to J&H Belmont LLC. The contracting party shall have the right to take pictures of the event as well; however, any commercial use of the likeness of the building or property is prohibited without the express written consent of J&H Belmont LLC.
- **Cancellation Policy:** The contracting party must provide a dated, written request for cancelation. If the date of the venue needs to be changed prior to 30 days of the contract date the contracting party may move contracted date one time to a new date if that date is available. There is a \$250.00 fee to change dates. The reservation deposit can be applied to the new date selected.
- **Assignment:** This contract may not be assigned in whole or in part by the contracting party, except with the prior written approval of J&H Belmont LLC.
- **Taxes and Gratuity:** All applicable state and local taxes will be imposed and payed by the contracting party. 18% gratuity will be added to the final contract price.
